Makes his stand against the accusations



"Yesterday, Venezuelans peacfully expressed their desire to find a Way Out of this government that has submerged us in misery. We take responsibility for those who marched yesterday. Their activty started, and ended, peacefully. There was no violence on their part. On February 12, the people who want change manifested. But, who wants violence? These violent acts after the march are the govenrment's doing, their sole responsibility, as they control the weapons, the military, and the police. Most of all, they are under obligation to safeguard the life of every Venezuelan."

Just minutes after the press conference had finished, a DGCIM (General Directorate of Military Counter-Intelligence) squad broke and entered Voluntad Popular's main office, in a display of violence, without a word, and with no warrant whatsoever.

The effectives asked "where is Carlos Vecchio?".

After searching the premises and verifying that they were in a state of normalcy, the squad left the site.

Democratic Unity Roundtable



On behalf of the democratic coalition, Democratic Unity Roundtable's executive secretary Ramón Guillermo Aveledo, called the Venezuelan Rechtsstaat into question. This he did in light of the alleged arrest warrant issued by the government against Leopoldo López. He also alerted the citizenry to a possible violation of María Corina Machado's parliamentary immunity. The Democratic Unity Roundtable released a communiqué urging the Executive branch to immediately disarm the socalled "collectives", and to release arrested protesters, in order to guarantee peace in the country.

"We demand that an end be put to imputations based on no evidence, to irresponsible accusations brought against Venezuelans, to any acts that would belittle social and political leaders. The word of the government, the State Power's deeds, speech from a minister or another high-ranking public servant, must recoup an air of respect, which itself begins with self-respect. The State's power cannot be a department for political propaganda. We therefore condemn all unfounded charges against Leopoldo López."

Radical Civic Union RCU

This delegation shall express their sympathies towards the victims of repression and their families. It will also take all relevant measures at the international level, so that the Venezuelan government will abide by the International Covenant on Civil and Political Rights, and the American **Convention on Human Rights.**
